

# Mr. Mark Demers, Grant Program Implementation Manager

- <u>Unite-Us Grant</u>- (American Rescue Plan-Negative Impact Grant)- \$6.1m per year effective July 1, 2022:
  - Data ingestion and secure data transfer for the platform and social connector has been slow but we are moving forward. As of April 11, 2023, we have <u>30,197</u> in the system. Completed latest SFTP data transfer to Unite Us on April 10, 2023. We have submitted <u>816</u> community partners and <u>313</u> healthcare partners for inclusion to the platform since August 2022.
  - Below is an activity snapshot from Unite Us Insights:



- Our Warner Robins GDVS office is ranked #6 (1496 Unite Us referrals received during the pilot program) and #8 (1299 Unite Us referrals received from October 25, 2022, to present) in the entire national network.
- Our latest data back from Unite Us on April 3, 2023, containing social needs indicators, via SFTP.
- Grant financial management- payments are 100% up to date since we received the advance.
- Attended Unite Us meeting April 3, 2023.

- Quarterly reports for both financial and grant were completed April 6, 2023, and transmitted via grant portal on April 10, 2023.
- <u>SSG Fox Suicide Prevention Grant Program</u>- (\$747,464 for one year with the possibility to extend two more years).
  - We are in partnership with Kennesaw State University AMES Center to implement the grant. KSU started analyzing data collection and the latest submission to the VA on April 4, 2023.
  - Payment for the Suicide Prevention summit (\$60,000.00) was completed on March 23, 2023.
     Second quarter funds draw for \$144,803.00 was completed on April 11, 2023, and the KSU invoice was paid on April 12, 2023.
  - Attended SSG Fox Grant meeting on April 3, 2023.
  - Attended Fox Grant Conference on March 27-30, 2023.
  - Calandra Ferguson provided the outreach and training data reports, and we transmitted it to the VA on April 4, 2023.
  - o Our first quarterly report is due on April 21, 2023, encompassing the first 6 months of the grant.
  - Fox Grant renewal notice was sent out to all recipients and is due to the VA via UDPaaS on May 19, 2023 (no exceptions).
  - Calandra Ferguson or Veda Brooks will report all the outreach and training events regarding Suicide Prevention under the Fox Grant.

# Mr. Bobby Davis, Director, Veterans Education and Training Division (State Approving Agency)

- The approval and compliance surveys of educational institutions, training establishments and training programs approved for veterans training is continuing with no significant problems in any area being noted.
- Approval of new veteran's On-The-Job training sites (OJT) continues to increase. As of this date the State Approving Agency (SAA) has granted approval to 1,824 educational institutions and training establishments where Georgia veterans may attend school or job training and utilize their GI Bill® educational benefits.
- April 5-7, the SAA staff participated in the 2023 Georgia VA Certifying Officials (GAVCO)
   Conference. Met with over 100 school certifying officials.

## Mr. Russell Feagin, Director, Health & Memorials Division

The FY 2024 Budget includes three bonds for activities involving the Health and Memorials Division (see attached). We will be presenting a resolution during the Board meeting which will need to be signed to accept the following bonds:

- 1) Expansion of the Georgia Veterans Memorial Cemetery-Glennville at Glennville, Georgia. This bond is in the amount of \$510,000. We will submit a grant application to the National Cemetery Administration (NCA) Grant Program for federal dollars for the expansion which is expected to cost about five million dollars. If the application is approved, actual construction would take place sometime in FY 2026.
- 2) Renovations to the Vinson and Wheeler Buildings for ADA compliance and other needed repairs. This bond is in the amount of \$2,005,000. We will submit a grant application to the State Home Construction Program for these improvements. This grant would be approximately \$3,700,000 for a total construction project of about \$5,700,000.
- 3) Paving of roads and parking lots within the Georgia War Veterans Home campus. This bond is for \$1,285,000. This project is not eligible for VA matching funds.

In addition to these new construction projects, we have received funding from NCA for improvements/expansion of the Georgia Veterans Memorial Cemetery in Milledgeville. This construction project should take place later this year. Since NCA did not approve our entire request for expansion, we will be submitting another application this year for the additional necessary expansion. If approved, this additional expansion would take place in FT 2026. The matching bond funds for both of these projects were approved in the FY 2023 budget.

## Ms. Tonya Jarrett, Clinical Director, Health & Memorials Division

1. Georgia War Veterans Home (GWVH) is COVID-free for veterans and staff. Due to the Baldwin County Transmission rate increasing from moderate to high on 4/7/23, the staff is now utilizing N-95 masks and face shields in all areas of the campus.

- 2. Health & Memorials division conducted a TEAMS meeting with Ms. Calandra Fergerson on 4/5/23 to discuss the Fox Suicide Prevention Grant Program and how we might incorporate the program at the GWVH. Our team also shared with Ms. Fergerson the Suicide Prevention and Intervention policy, Behavior management policy, PHQ9 Screening Assessment, Initial Suicide Assessment Form, and Suicide Assessment Follow-Up Forms used in our clinical platform at GWVH.
- 3. We have an onsite meeting scheduled with Ms. Calandra Fergerson and Ms. Veda Brooks on 4/28/23 to tour the GWVH, meet the behavioral team staff members, and continue to review areas that the Fox Suicide Prevention Grant Program may be utilized within the clinical framework of the GWVH.
- 4. Met with the Executive Director of the GWVH to discuss the upcoming *Let's Connect Summit for Suicide Prevention* in May 2023 to identify potential GWVH staff for participation.
- 5. Health & Memorials continues working with the Georgia Department of Administrative Services (DOAS) to evaluate vendor responses for bidding on the Georgia War Veterans Home contract to become effective on 7/1/23.
- 6. Status of staffing by Pruitt Health for Subacute Unit- no change from February
  - a. Psychiatrist-Pruitt Health is pursuing a contract with Salveo Integrative Health for psychiatry services with a start date to be determined.
  - b. Neuropsychologist- Pruitt is contracting with consultant Dr. Jeremy Hertza through Integrated Psych Solutions.
  - c. LPN/RN- Pruitt is continuing to recruit.
  - d. OT/PT/SLP- Pruitt is continuing to recruit.
- 7. Status of staff training and program development
  - a. Ongoing modality training for Eye Movement Desensitization and Reprocessing therapy (EMDR), biofeedback training, and dynavision training for sensory processing.
  - b. Pruitt staff continues to provide patient de-escalation and safety training campus wide.

#### Mr. Carlton Deese, Executive Director GWVNH, Augusta, GA

House Resolution 77 - The General Assembly approved as part of the appropriation and budget legislation, state funds in the amount of \$1,000,000.00 dollars to create a state veterans cemetery in Augusta, Richmond County. Although approval of the initial funding for the proposed cemetery paves the way for architectural planning, surveying of the property and purchasing of the land, the next phase in the process will involve securing funding (an annual federal grant) from the U.S. Department of Veterans Affairs and state supported dollars for the purposes of construction of the cemetery, purchasing of equipment, and future hiring of personnel to operate the proposed cemetery.

\$1,000,000 dollars removed (HB 911) will be added to the FY 2024 budget into the Georgia Veterans Memorial Cemeteries program during the new fiscal year.
