# **Accounting/Procurement:**

- We are establishing a Purchase Card program at Georgia Department of Veterans Service. All of the
  paperwork has been submitted, background checks for the card holders are in progress, and training
  for all those involved is nearly completed. The last class is for the two Program Administrators and
  will be in late February 2024. We expect the program to be fully operational in March 2024.
- Mark Demers completed the Primary Governmental Accounting Series (Intro to Government Accounting I, Intro to Governmental Accounting II, and Intermediate Governmental Accounting) on November 19, 2023.
- Mark Demers completed the Purchasing Card CFO training and Purchasing Card Approver training modules on November 27, 2023.


- Irene Mackson completed all but one Purchasing Card training module for the P-Card Administrator role.
- On December 7, 2023, GTA reported to the State Accounting Office (SAO) that they experienced an outage related to print/ mail services, as Xerox is unable to print files sent by agencies. This affected the printing of paper checks for Accounts Payable and Payroll for new employees. On December 11, 2023, GTA/SAO found a solution for the payroll for new employees' issues. Shareka Monday-Robinson adjusted the prenotification function in the payroll system to allow the first employee paycheck to be direct deposited. As of December 12, 2023, Xerox is still in the process of resolving the network issues and resuming print operations. Currently, the networking issue is being remediated, testing and printing will begin as soon as the issue is resolved. (As of the date of the Board meeting, this issue was resolved, and all pending checks have been mailed out).

#### **Budget:**

• We are looking forward to the start of the 2024 Session of the Georgia General Assembly on or about January 8, 2024, as we prepare to present our AFY 2024 and FY 2025 budget request.

#### **Grant Program:**

- SSG Fox Suicide Prevention Grant Program- (\$747,464)
  - We are in partnership with Kennesaw State University AMES Center to implement the grant.
     The latest data was transmitted to the VA on December 6, 2023.
  - Calandra Ferguson provided the outreach and training data reports, and we transmitted them to the VA on December 6, 2023.
  - Calandra Ferguson or Veda Brooks will report all the outreach and training events regarding Suicide Prevention under the Fox Grant.
  - Irene Mackson attended the Fox Grant In-Person Technical Assistance (TA) / Post Award Conference (PAC) Event for December 4-7, 2023, in Orlando, Florida.
  - The end of year FER/FFR reports are due February 15, 2024.
- <u>Unite-Us Grant</u>- (American Rescue Plan-Negative Impact Grant)- \$6.1m per year (\$18.3m) over the course of 3 years starting July 1, 2022:
  - Data ingestion and secure data transfer for the platform and social connector is moving forward. As of December 7, 2023, we have <u>266,501</u> veterans in the system. We have submitted <u>956</u> community partners and <u>313</u> healthcare partners for inclusion to the platform since August 2022.
  - The next quarterly reporting is due January 2024.
  - O Below is an activity snapshot from Unite Us Insights:



- Veterans Mental Health Services Program Grant (HB 414)- Georgia Governor Brian Kemp signed HB 414 on April 25, 2023, with the support of state legislators and the Georgia Department of Veterans Service (GDVS). The bill creates the Veterans Mental Health Services Program, which is a grant program to improve access to mental health services for military service members, veterans, and their families in the state of Georgia. The grant program is funded through state appropriations in Fiscal Year 2023. The total grant funding is \$750,000 for FY2023 (executed by no later than 30 June 2023). The grant was awarded to two vendors:
  - Aspire (Cohen Veterans Network) for \$650,000.
  - Emory Healthcare for \$100,000.
  - The money was allocated to both awardees, and they have received the funds.
  - The first quarterly reports received on October 23, 2023, and both agencies are in compliance with grant guidelines.

# **Veterans Service Foundation:**

- The Veterans Service Foundation Board held a special meeting on November 30, 2023, to discuss hiring a fundraising consultant. We are going to use Survey Monkey to select a consultant. The tentative go live date will be January 2, 2024.
- The next special board meeting will be on February 29, 2024, for fundraising.

- The Veterans Service Foundation Board held its quarterly meeting on December 7, 2023, and discussed immediate and long-term priorities.

#### INFORMATION OUTREACH

#### **Division Updates**

- 1. GDVS Newsletter PID published a monthly newsletter in November. The e-newsletter features top stories from the month and encourages readers to get the full issue at <a href="https://veterans.georgia.gov/newsletter">https://veterans.georgia.gov/newsletter</a>. The November edition highlighted Veterans Day celebrations in Georgia , including the ceremony in the State Capitol and message from Commissioner Ross, as well as updating veterans on the availability of services like the National Cemetery Administration's addition of 5 million veterans to the Veterans Legacy Memorial. The newsletter also reminded veterans and families of the upcoming Wreaths Across America ceremonies in Glennville and Milledgeville and updated them on the department's participation in a holiday tree festival with a suicide prevention tree.
- 2. Wreaths Across America worked with GDVS cemetery directors on programs for their annual wreath ceremonies. External Affairs updated designs and information for the events, then provided final products in a timely manner. Additionally, we have focused on raising awareness and support for the wreaths programs across social media for donations and to spread awareness of the upcoming ceremonies.

 Suicide Prevention and Awareness Outreach materials – worked collaboratively with Executive Director Simpson, Chief Development Officer Demers, and Suicide Prevention and Outreach Coordinator Fergerson to develop a new line of printed materials targeted on spreading awareness of mental and behavioral health resources for veterans in crisis.

Materials include a retouched version of the resource guide originally produced in October, a series of trading cards also featuring information on the Governor's Challenge, and half-page flyers to teach how to recognize signs of suicidal thought. These materials will be used at outreach events and distributed to Governor's Challenge partners across the state.

#### 4. Holiday Loneliness Campaigns -

- a. Unite Us working collaboratively on a text and email campaign to raise awareness of resources available to veterans with high social needs scores surrounding military bases and high veteran population areas. The campaign went live on 12/11/23 in a two-pronged approach. Veterans received an email from GDVS and a text message from Unite Us offering assistance. So far, this is the most successful proactive outreach campaign with Unite Us. 39 veterans have requested assistance, and a second outreach attempt will launch on 12/18/23.
- b. Miner Agency using Fox Grant funds after the Fox Forum in October, the GDVS is launching a holiday campaign from 12/15/23 to 1/15/24 targeting veterans who may need mental health support during the holiday season. The Miner Agency has developed 6 vignettes or slides for use on Facebook and other media to spread awareness of help to veterans, active duty service members, and their families.

# **Veteran Service Board Responsibilities**

The Veteran Service Board (VSB) is covered under GA Code § 38-4. The VSB is primarily advisory in nature. Board members are above all leaders, facilitators, and communicators on veterans' issues.

While not codified in law, the basic responsibilities of board members are:

- Preparing for board meetings. Setting the agenda, determining meeting dates, etc.
- Engaging with the Commissioner. The board acts as a bridge between the veterans within Georgia and the Commissioner ensuring proper communication.
- Facilitating Internal Communication. Board members work together to bring out the best value out of each board member, making sure everyone is heard.
- Three elected positions: Chair, Vice-Chair, and Secretary.
  - Chair: Calls the meeting to order, determines if a quorum is present, announces when the board arrives at a decision, helps steer the meeting and keep discussions to the point, and enforces rules when needed.
  - Vice-Chair: Fills in for the Chair if they are not available.
  - Secretary: Ensures the accuracy of the meeting minutes.
