Mr. White announced that the remains of US Army PFC Lither Elwood Bagley have been identified. Bagley, a member of Merrill's Marauders, was inducted into the Georgia Military Veterans Hall of Fame in 2023. His remains will arrive in July and full military funeral arrangements will be announced at that time.
