Georgia's veterans have an opportunity to fly free of charge and visit war memorials in Washington, D.C., thanks to Middle Georgia Honor Flight.

The tours include trips the World War II memorial, Korean War memorial, and Vietnam War memorial. They also provide for veterans who are terminally ill and wish to honor the fallen.

Thanks to the generosity of donors, sponsors, and volunteers, veterans have been able to experience these memorials that pay tribute to their service.

In a recent broadcast on Macon's WMAZ—TV, Vietnam War veteran and Warner Robins native, Bill Carey, provided comments the closure this trip brought him. "It's really important that these veterans do this to get the healing from the inside. It was being able to touch their names, it was the spot where I was healed," said Carey.
