
For the past two years, our annual public Memorial Day remembrance ceremonies at our Milledgeville and Glennville veteran cemeteries have been on hold due to the pandemic.


### A CELEBRATION OF SERVICE: HELEN POPE

# GDVS MAKES A POSITIVE IMPACT AT THE WE CARE VETERANS RESOURCE FAIR

When he was reduced to a 40% disability rating after being at 100% for 5 years, Army veteran John Byrd didn't know what to do. "I felt lost and had nowhere to go," he said. Then he met and received hands-on assistance from GDVS veteran service officers at the recent *We Care Veteran Resource Fair* in Cobb County.

"They helped me put in an appeal, which makes it a lot easier. They were patient and very astute on what to do," he said.

Similar words of gratitude echoed through the Cobb County Civic Center during the two-day veteran resource fair on May 13 -14. The GDVS was among hundreds of professional organizations and agencies in attendance to give solutions to the veteran community.

The GDVS assisted nearly 400 veterans over the two day fair. Veterans of all ages, ranks, and branches of service, no matter where or when they served, came to find help with their questions.

GDVS Director of Professional Development and Training, Ramona Roper, said the event exceeded her expectations. "Some veterans came with paperwork, others came with family members, but most came on their own with nothing but a question, a concern, or a simple need for help. I am glad we could make connections and get them the benefits they have earned," she said.

"Being able to bring the claim process out to the public was the best part," said North Region Director Ken Childre. "For those veterans who either don't know we have offices or are too afraid to come into our offices, this gave them a chance to 'stumble into' our room and see what we are all about."

For many veterans, filing a claim was challenging because they may not have known what to do, thought it was too difficult, or that it was too late.

"Some veterans have been separated from service for quite some time and had no idea it was easy to get assistance filing claims," explained Assistant Director of Professional Development and Training, Steven Fay, who spent time showing and helping veterans how to take the steps they need to make the process simple - steps Air Force veteran Joe Revit "blew off" when he left the military.

"When I left the service, I didn't do anything with the VA. I thought I would get to it later, but having this as a conduit makes it easy," he said.

GDVS Commissioner Patricia Ross gave a huge thanks to the GDVS training team, appeals division, and the North region veteran service officers who attended the fair. "It felt like a team coming together for the greater good of the veteran and military community."
