Ms. Swan called the meeting to order at 12:30 p.m. Mr. Peterson gave the invocation. Mr. Kopsie led the Pledge of Allegiance to the Flag.

Mr. Kopsie made a motion to approve the March Agenda. Mr. Mendez seconded the motion. The motion passed.

Mr. Mendez made a motion to approve the February minutes, which were previously distributed for members to review. Mr. Kopsie seconded the motion. The motion passed.

Mr. Mark Shreve, State Commander, The American Legion

- 1. Department Officers attended the Washington Conference virtually to promote our legislative priorities.
- 2. American Legion Department of Georgia membership is number 1 in the southeastern region and ranks 20 out of the 55 departments nationally.
- 3. Department Headquarters continues to plan the March Conference, April National Commander's Visit and June Convention.
- 4. The Blood Donor program has exceeded the stated goal and the American Legion has donated over 1,200 pints to date.
- 5. Augusta will host American Legion Family Day in April to support the Commander's Project. The banquet is sold out.
- 6. Commander Shreve has completed 76 out of 100 Post visits throughout the state in 2022. There are 223 American Legion Posts in Georgia.
- 7. Representatives of the American Legion attended the Decommissioning Ceremony of the Eagles Nest at the Atlanta VA.
- 8. Commander Shreve spent 10 days in South Georgia visiting veterans in Cordele, Tifton and Valdosta to better understand the needs of veterans in this region.
- 9. The American Legion Department of Georgia celebrated American Legion Date Night across the state.
- 10. The Commander's Project is on track in fundraising efforts. The Commander's Project goal is \$100,000.00 and the funds will be allocated and presented at the Department Convention to VAVS programs as well as Volunteer Services at the Georgia War Veterans Home.

Mr. Mark Demers, Training Team, GDVS, American Legion Service Officer

- The Department Service Officer attended the American Legion Department Adjutant Teleconference on February 17, 2022 at 1930.
- The Department Service Officer attended the American Legion National Veterans Affairs and Rehabilitation Commission Meeting on March 5, 2022 at 1000 via Zoom. We heard presentations from Dennis McDonough (Secretary, VA), Dr. Carolyn Clancy (Assistant Under Secretary for Health Discovery, Education & Affiliate Network, Veterans Health Administration), Mr. Michael Frush (Principle Under Secretary for Benefits), and Matthew Quinn (Under Secretary for Memorial Affairs). They discussed health care modernization, toxic exposure and burn pits (to include the proposed new presumptive conditions, improved healthcare for women, Guard and Reserve GI Bill).
 - Secretary McDonough stated that they expect to place 38K homeless veterans into permanent housing by the end of 2022.
 - Secretary McDonough stated that the VA expects at least 2,500 veterans over the next 10 years will be affected by the 14 new burn pit cancer presumptive conditions. They are also working on adding more.
 - Secretary McDonough would like congress to pass the 2022 budget instead of continuing resolutions because it could cause a 1-billion-dollar shortfall.
 - Secretary McDonough stated that there was a 300K backlog of disability exams even though the VA is completing 38K exams per week.
 - Certificates of Eligibility can now be sent instantly to lenders.
 - Secretary McDonough stated that they are now using an automated claims process that can complete claims in 3.5 days.
 - Secretary McDonough stated that the VA is testing automated Notification Letters instead of mailing them.
 - Also discussed were predatory non-accredited claims companies preying on veterans. They are looking for compelling stories they can present to Congress in April 2022.
 - The Asset and Infrastructure Review (AIR) Commission recommendations will be published on March 14, 2022.
 - We are awaiting the presentations from this American Legion event to distribute.
- The Department Service Officer updated, published, and distributed the 2nd Edition of the Post Service Officers Guide (2022) on March 3, 2022 to all Post Service Officers and Commanders within the American Legion Department of Georgia. The document is a 50 page how to, and reference guide for Post Service Officers.

- The Department Service Officer is attending the American Legion Department Service Officer School on March 7-27, 2022 via online format presented by Bergmann & Moore.
- The Assistant Department Service Officer (Ed Kent) assisted 19 veterans with VA benefits related inquires this month.

- The Department Service Officer attended an Atlanta VBA Regional Office Directors/VSO Quarterly Zoom meeting with Director Tony Milons, Assistant Directors Angela Seelhammer, Patrick Zondervan, and Staff on the changes within the Veterans Benefit Administration (VBA to include compensation, veteran readiness and employment, loan guaranty and education held on February 22, 2022, at 10AM).
- The Department Service Officer attended the Atlanta VAHCS VSO board teleconference Webinar meeting with Director Brown held on February 23, 2022, at 12:30PM. The Director provided an update on the hospital personnel shortages, celebration ceremony for former residence of the Eagles Nest Community Living Center, the opening of new Community-Based Outpatient Clinic (CBOC), the Community Care Program under new management, an update on the Atlanta area Fisher House, the Vet Atlanta Mega Summit, and a mobile Mammography Unit at the Arcadia Clinic. A summary of the meeting was provided to the VFW Commander, Staff, and community.
- The Department Service Officer attended the VFW Post 4706 Award Banquet held on February 26, 2022, at 6PM at 5362 Covington Hwy, Decatur GA 30035. The Post presented awards to the VFW Post Voice of Democracy (VOD) awardee, Patriot's Pen awardee, JROTC awardee, Decatur NAACP Chapter awardee and Post Volunteers awardees. The VOD and Patriot Pen awardees are Middle and High School students.

Ms. Amy Stevens, Georgia Military Women and VETLANTA

Georgia Military Women continued with many activities this past month including in person and online sharing of resources, education, and smiles across the state. This past month included a Mardi Gras bus trip for some members to New Orleans, attendance at events at the Alliance Theatre in Atlanta sponsored by Home Depot, support to Soldiers' Angels food drive and numerous small meetup groups across the state. A women veteran only event at the GA Aquarium will be held March 13-14 sponsored by Life Waters, a national non-profit promoting aquatic recreation.

GMW has also continued to work on outreach activities. This past week, a strategy meeting and luncheon with women veterans was held in Augusta, GA. We are also continuing to have monthly collaboration virtual meetings with the VISN 7 Women Program Managers at the Georgia VA Hospitals. The Charlie Norwood VA WPM has resigned her position and that position is being covered in interim by the Women's Medical Director.

For VETLANTA, we are progressing on emerging from pandemic challenges. We are actively engaging more and more organizations through networking. Our Feb 10th Q1 Summit at the 12 Hotel in Atlanta brought about 200 individuals together. Our Q2 Summit scheduled for May 3rd has been postponed but new plans should be announced in the next week or so. Meanwhile our role with the CVEB expands. Dr. Walker, VISN 7 Director, held a special partnership meeting and covered important topics on suicide prevention and caregivers. This provided opportunities to share resources in the community that the VA was not aware of. An additional topic was training of VSOs on benefits and claims. As these partnership meetings continue, it is expected that there will be greater collaborations throughout the state.

Commissioner Patricia Ross

Commissioner Ross went over the new logo options with the Board and is looking forward to their input.

There was a discussion regarding CRDIRS (Certificate of Release and Discharge Information Reporting System), a program administered by the Defense Manpower Data Center. The program will give us access to DD214's for everyone being discharged from the military and choosing to make their residence in Georgia. We will be able to send them a welcome home letter, along with the contact information for our various services. We will also be able to search for DD214's and retrieve the information provided on the forms.

Commissioner Ross is moving toward a comprehensive list of Georgia's veterans and is working with UniteUs, the VA, DDS, CRDIRS, etc. to develop this database. We should know if the UniteUs grant has been approved within the next couple of weeks.

Commissioner Ross announced that the VA released information regarding an upcoming grant for suicide prevention. She attended the Georgia Suicide Prevention Task Force monthly meeting earlier today and is looking forward to working with others to apply for the grant. Mr. Mendez asked if there could be a less cumbersome way for veterans to get someone on the line when they are considering suicide, such as a 911 number. Commissioner Ross announced that the number will be 988 and will go into effect on July 1st. Mr. Hanley stated that there are companies creating plans and algorithms to begin reaching out to veterans who may be suicidal. Commissioner Ross stated that UniteUs also does predictive analytics for veterans at risk.

On Thursday, February 17, 2022, Commissioner Ross attended the subcommittee meeting on taxing veteran's retirement pay at the Capitol. She also met virtually with the State Workforce Development Board. The Commissioner then had a meeting with UniteUs and Kaiser Permanente. In the evening, she spoke for the Greater Georgia Black Chamber of Commerce History of Black Business event, along with Ms. Ramona Roper, Director of Training and Professional Development.

On Saturday, February 19, 2022, Commissioner Ross spoke at the evening banquet for the VFW's Mid-Winter Conference, located this year at the Macon Marriott Center. Her remarks were about the changes in the department to include the veterans' driver's license, support military retirement tax exemption and collaboration with other VSOs to better support our state's veterans.

On Sunday, February 20, 2022, Commissioner Ross flew to Washington, D.C. for the NASDVA Mid-Winter Conference. The conference lasted until Wednesday, February 23, 2022. The conference centered around updates from the VA and speakers includes Secretary McDonough, VHA, VBA, DMC, Women Veterans Center, etc.

On Thursday, February 24, 2022, Commissioner Ross met with HRA for a "Compensation Discussion" and HRA will complete a market analysis on GDVS positions. She then briefed the House Appropriations Human Resources Subcommittee regarding the FY23 budget with the four priorities of providing the \$5K increase to vacant positions (1 July 2021) that are now filled, the \$3K raise for employees making less than \$50K, a new position for suicide prevention and outreach, and a grounds maintenance worker for the Glennville Cemetery.

On Friday, February 25, 2022, Commissioner Ross attended the Monthly Food Distribution for Veterans sponsored by Soldiers' Angels and Amazon at the Atlanta VA Arcadia Clinic in Decatur. She helped distribute food to about 200 veterans and their families. Later in the evening, she attended a Veterans Coalition Meeting at Der Biergarten Restaurant.

On Monday, February 28, 2022, Commissioner Ross held a weekly Director's Meeting. She then had a meeting with Jim Seward of the Council on Criminal Justice about his national work on justice involved veterans and initiatives to identify predictors and treatment.

On Tuesday, March 1, 2022, Commissioner Ross attended the Women Veteran's Legislative Breakfast, along with other women veterans from GDVS. Later that morning, she had a meeting with Veda Brooks, Director of the Women Veterans Office. She spent her afternoon meeting with Secretary Will Grimsley of the South Carolina VA. South Carolina has graciously shared their strategic planning documents as a template for Georgia.

On Wednesday, March 2, 2022, Commissioner Ross attended a meeting at the Georgia War Veterans Home with Assistant Commissioner Mark Bannister, Executive Director of the home Dennis Mize, Clinical Director of the home Tonya Jarrett, and PruittHealth Staff Members: Chief Medical Officer Dr. Rayvelle Stallings, Chief Clinical Officer Fran Ranier, and Area Vice-President Tyler Arnold. The group toured the campus, specifically the 14-bed transition support unit and the Russell Building. Further planning meetings were scheduled as the estimated opening for the transition support unit is 1 July 2022.

On Thursday, March 3, 2022, Commissioner Ross had SHARE training with Trainer Steven Fay. She then had a meeting regarding ADA Title I and FMLA with Stacey Peace. The Commissioner met with William Martin regarding the Augusta, Atlanta and Dublin VA and AIR Commission's plan to be released 14 Mar concerning long-term plans for VA facilities. Her day ended with a follow-up meeting on VISN 7 Virtual VSO Summit with VISN 7's commitment to assist with training, specifically in suicide prevention and mental/behavioral health.

On Friday, March 4, 2022, Commissioner Ross had Mr. Kerry Dyer release the same workforce survey previously sent to the department to provide a baseline. The survey closes out 31 March. She also had a lunch meeting with Veterans Service Board Secretary Josh Kopsie and Dr. Brian Moore, Director of the Center for the Advancement of Military and Emergency Service Research. Based on the tremendous work by Dr. Moore, we are engaging his expertise with the transition support unit (Milledgeville) and our suicide prevention efforts.

On Monday, March 7, 2022, Commissioner Ross held a weekly Director's Meeting. Later that day, she attended a departmental budget meeting, and all programs are in the green financially. Based on the update, the department is pursuing the purchase of a van for IT's use as they travel state-wide delivering equipment and the current van is not dependable. She also attended new VSO training around scheduled meetings.

On Tuesday, March 8, 2022, Commissioner Ross attended new VSO training, and that afternoon attended the first planning meeting on the transition support unit with Pruitt Health, Mr. Feagin and Ms. Jarrett in Norcross. Results from the meeting include senior members of Pruitt Health now having a better understanding of the department's expectations and new working groups to begin planning for staffing and operating the transition support unit.

On Friday, March 11, 2022, she held a monthly VSO Teams meeting to provide an update on initiatives within the department and to answer questions from the field. Later in the day she met with Mike Wang and General Ni from Taiwan Veterans for Atlanta.

On Sunday, March 13, 2022, Commissioner Ross attended and spoke at an event sponsored by LifeWaters.org in conjunction with the GA Aquarium's Veteran Program, Georgia Military Women and Humble Warriors. The event was a "woman veteran only" dive experience at the Georgia Aquarium. LifeWaters specializes in SCUBA diving training for disabled individuals (veterans, civilians, first responders). Any individual with a VA disability or civilian diagnosed with: Spinal Cord Injuries, Post-Traumatic Stress Disorder, Traumatic Brain Injury, Amputees, Multiple Sclerosis, Amyotrophic Lateral Sclerosis, Cerebral Palsy, Spina Bifida, and Multiple Traumas and other disabilities may be involved in the scuba training program. The Scuba diving skills are adapted for each disabled diver. They work with Aquariums across the country.

On Monday, March 14, 2022, Commissioner Ross briefed the Senate Appropriations Human Resources Subcommittee regarding the FY23 budget.

The GDVS website also now specifies that NOAA and Public Health Service veterans are qualified to receive certain benefits.

Mr. Russell Feagin, Director, Health & Memorials Division

Mr. Feagin announced that they have received budget expansion funds for the Milledgeville Cemetery, which will run out of developed space within the next four years. They need to expand, and there is the possibility of expansion in Augusta. They are close to completion of the Wheeler Building and the Transition Support Unit (formerly called the Sub-Acute Unit). The building will be physically ready to admit patients on July 1st. PruittHealth is currently working on the staffing.

Tonya Jarrett, Clinical Director, Health & Memorials Division

Ms. Jarrett discussed the meetings with PruittHealth to work out policies, procedures and staffing requirements. They currently plan to meet every two weeks, alternating between PruittHealth's offices in Norcross and Microsoft Teams.

Ms. Jarrett announced that they have remained Covid free during the month of March. They are currently having to wear surgical masks only because the threat level is moderate. They do respiratory

checks every 24 hours. There is no testing conducted because there is no active outbreak and no positive cases.

Mr. Bannister announced that today is crossover day in the legislative session. The AFY22 budget has been approved. We are waiting for Governor Kemp to sign off on it. Mr. Bannister then highlighted various budget items on his report, which follows.

FINANCE

Accounting

Our Director of Accounting, Mr. Chris Hambright, briefed GDVS' current annual operating budget (AOB) on Monday, March 7, 2022, to senior staff closing out the 3rd quarter and was advised by our accountant we are in good shape in all fiscal programs as we approach the final quarter of FY 2022. Other routine operations are continuing.

<u>Budget</u>

AMENDED FY 2022

On Tuesday, February 15, 2022, Commissioner Ross presented GDVS' Amended FY 2022 budget to the members of the Senate Appropriations Subcommittee on Human Development.

As of this dated correspondence, the Governor has not signed the Amended FY 2022 appropriations and budget. GDVS requested approval of appropriated funds in AFY 2022 to support COLA adjustments for <u>all</u> vacant positions within our department to address agency recruiting needs. Our request was recommended by the House and approved by the Senate in the AFY 2022 budget as previously omitted in the original bill.

FY 2023

On Thursday, February 24, 2022, Commissioner Ross presented the Governor's Recommended Budget for FY 2023 to the members of the House Appropriations Human Resources Subcommittee.

Commissioner Ross is scheduled to brief our FY 2023 budget to the Senate Appropriations Human Development Subcommittee on Monday, March 14th, 2022, at 10:00 am. This most likely will be the final budget brief to the members of the General Assembly for the 2022 Session before SINE DIE.

As of this writing the House has approved their version of the FY 2023 appropriations and budget, HB 911, and sent their recommendations to the Senate for review. The Senate Appropriations Committee has drafted their version of the approved FY 2023 budget and has not yet released it for executive agencies review. It is anticipated that their Senate Bill will be released on March 10th or 11th following my report.

According to S.R. 382, March 15th, 2022, is designated as legislative day 28 (Crossover). Following Crossover Day, the House of Representatives will convene for the remaining scheduled legislative and committee days for this session until day 40 (SINE DIE) on Monday, April 4th, 2022.

Commissioner Ross added that Sen. Kirkpatrick's study committee will assess the veterans homes and locations and the need for more in Georgia.

The April 14 board meeting was scheduled. It will be a combination virtual and in-person meeting, set up at the GDVS. Mr. Hanley made a motion for this and there were no objections. The motion passed.
